RENTAL AGREEMENT

Discover Aquatics shall be available for use by registered individuals or groups on a reservation basis, subject to the conditions outlined below. The purpose of these guidelines is to establish standard procedures for administering the policy and to insure fairness in the rental of the facility.

The applicant granted the reservation, agrees to read and abide by the following:

1. User agrees to identify and hold harmless Discover Aquatics, its agents and all employees from and against any claims for damages to persons or property arising out of any use of the facility by the user. Discover Aquatics assumes no responsibility for any property placed in or about the facility.
2. User agrees to assume all responsibility for all damages done to the premises as a result of their usage. User shall assume the costs for repair and/or replacement value based on the Discover Aquatics assessment of the damages. A \$200 damage deposit will be collected prior to the usage. If no damages are caused during usage then deposit will be refunded or shredded within 10 business days of the rental date.
3. No oral agreements, for the use of the Discover Aquatics facility, shall be valid. All reservations must be confirmed with a signed Rental Agreement, signed by both the Discover Aquatics employee and the pool renter. **The contract must be returned to Discover Aquatics with damage deposit of \$200 and full payment upon signing to guarantee rental.** Liability waivers are due prior to swimmers being allowed in the pool area on the day of the event.
4. Discover Aquatics will retain full amount on any rental with a cancellation of less than 10 days. If cancellation is due to illness or emergency, Discover Aquatics will reschedule your rental to the next available date.
5. User is obligated to the entire time reserved on this contract. Set up time is allowed no more than 5 minutes before the reserved rental time. Any amount of overtime is charged as an additional ½ hour and is subject to a \$50.00 charge. This will be billed at the end of the rental.
6. Discover Aquatics birthday party package is limited to two (2) birthday children at a time.
7. Discover Aquatics will set up and clean the facility prior and afterwards with all coordinated parties.
8. Discover Aquatics Lifeguard will take approximately 5 minutes at the beginning of the pool use to go over the rules and pool regulations with everyone at the poolside. This will be part of your scheduled time and is subject to taking longer than 5 minutes pending on the prompt arrival of your guests. All participants on premises must abide by all pool rules.
9. All participants are subject to a swim test (swim 75 feet with a recognizable stroke and tread water for 1 minute). This may be administered by the lifeguard in order to swim or participate in the deep end.
10. Non-swimmers must be accompanied by an adult swimmer in the shallow end. Life vests do not substitute for the capability or presence of a swimmer. Air filled swimming aids such as floaties/water wings are not allowed.
11. Children that are not potty trained must wear a non-disposal swim diaper while in the pool. (This can be purchased at Discover Aquatics.)
12. Food or beverages (except water) is not allowed in the pool area or in the locker rooms. Alcoholic beverages, glass bottles and tobacco products are **NOT** permitted anywhere on the premises.
13. Discover Aquatics reserves the right to cancel any reservations at anytime. All of the above rules and regulations are legal and binding in the court of law.
